1. Use the Φ 1mm access probe to detect the opening, with the force of 1N.
2. The sample was placed in the test chamber, the amount of talcum powder to be used is 2 kg per cubic meter of the test chamber volume. During the test, the sample was kept in a vacuum state with a maximum depression of 2 kPa (20 mbar), the extraction rate is less than 40 volumes per hour. The test is continued a period of 8 h.

IPX6

1. Internal diameter of the nozzle: 12.5mm
2. Delivery rate: 100 L/min
3. Distance from nozzle to enclosure surface: 2.5~3 m
4. Test duration: 3 min
